The invocation was led by Brett Harrison. The roll was called to establish a quorum. District #1: Absent; District #2: Present; District #3: Present; District #4: (Cedric Hudson not present during roll call but arrived at 6:08 p.m.) Present; District #5: Present.

ITEM #4: Adoption of the Agenda

Motion by Benjamin Eaton to adopt the agenda and seconded by Anthony Long. **Motion carried.**

ITEM #5: Adoption of the Minutes

Motion by Anthony Long and seconded by Benjamin Eaton to ratify the hiring of Jonathan Thurber and Paul Thurber as part time paramedic drivers at \$11 per hour in the Ambulance Department. Three yeas; one abstention: District 4 – Cedric Hudson. **Motion carried.**
